Notice is hereby given that on May 13, 2022, the Evaluation Committee scored and ranked all qualified submissions for RFP01-2202744B01-HSTASM-XXXXXX; and is proceeding to virtual interviews with the following proposers:

The shortlisted proposers shall provide a live demonstration of the following scenario:

### Scenario

1. A student is utilizing one of our approved Learning Management Systems (refer to the RFP for approved LMS list) to access our course content and assessments. Simulate a student entering the assessment area to take the assessment. Next, show how a student would be sent to the assessment in the assessment engine tool and take the assessment within the cloud. At a minimum, show how the following two data points would populate the student's gradebook area in their originating LMS: student score and teacher feedback.

Shortlisted proposers are expected to explain the solution's ability to support this functionality for all FLVS supported LMS's. Since we deliver courseware and assessments to each customer's LMS, we need an assessment solution that is cloud-based and forgoes the need to load the assessment into their individual instance of the LMS.

2. Demonstrate your analytics capabilities and question types/creation.

The results shall factor into scoring criteria "1. Quality of the presentation demonstrating ability to meet or exceed the requirements of the sample exercise" specified in Section 2.6.4 of the RFP. The exercise will be included in the meeting invitation.
